



# Georgia Quilt Show - Entry Rules

**Entry deadline - mail by September 1, 2010**

NQA certified judges will award a \$1,000 Prize for Best of Show and an additional \$4,500 for First, Second and Third place awards in each of three categories: Bed Quilt, Large Wall Quilt and Small Wall Quilt. Ribbons for Honorable Mention and Judges' Choice will round out the recognitions.

**NOTE: Prize winning quilts are required to travel with Original Sewing & Quilt Expo Fall 2010 events and will not be returned until after December 1, 2010.**

1. Enter each piece by submitting entry blank, entry fee, and images of the completed work.
2. Limit two entries per person, **one quilt per category.**
3. Quilt must be constructed and quilted by person(s) named on entry blank.
4. All quilts must be quilted by hand, by machine, or both.
5. Quilts must have a sewn on sleeve for hanging.
6. Quilts should be in excellent condition and have been completed between August 31, 2008 and August 31, 2010.
7. A quilt that combines two or more techniques (other than quilting) should be indicated as Mixed Techniques (i.e., piecing/appliqué, appliqué/embroidery, piecing/trapunto, etc.)
8. Quilt Sizes: (Must fit dimensions listed for category. A label identifying the maker to be stitched to the back lower edge of the quilt.)
  - a. **Bed-sized quilts** must be 60" to 110" in width and a length of 80" or more.
  - b. **Large wall quilts** must be 49" to 110" in width and a length of 40" or more.
  - c. **Small wall quilts** must be 12" to 48" in width and a length of 18" or more.
9. Description/history - please use this space to tell us what inspired you to make this quilt. Was it a guild challenge? Is it an original design? Why did you choose the fabrics?
10. Quilt must be available for judging and display from October 10 through October 17, 2010.  
**Note: Prize winning quilts are required to travel with Original Sewing & Quilt Expo Fall 2010 events and will not be returned until after December 1, 2010.**
11. Full-view photo must show all edges of the finished quilt. Detail photo must show the quilting stitches.
12. All decisions of the jurors and judges are final. MS. Productions, Inc. reserves the right to reject any entry, including those that fail to follow the quilt contest rules.

To enter, send:

- (a) Completed and signed entry blank with correct category circled.
- (b) Digital images on a CD-ROM or photo print out - no modification including cropping and color correction (one full view of completed quilt and one detail of completed quilt), using a minimum of 4 MP (megapixel) camera, on highest resolution setting, saved as a jpeg or tiff file (be sure to label with your name and title of the work). CDs will not be returned.
- (c) Entry fee: \$25.00 per quilt.
